- <u>HP Care Packs</u> Each model laptop has warranties based on the expected lifecycle of the device as well as how long each student will have each model laptop. These Care Packs ensure that any damage that may occur is covered to minimize any downtime, ensuring there is no learning loss due to any laptops not function correctly
- <u>Microsoft Autopilot</u> This service ensures all laptops are pre-provisioned with all the needed software as well as security settings needed for all student laptops
- <u>Asset Tag Managment</u> All newly deployed laptops have Asset Tags placed when being configured. This service is used in tandem with our asset management system (IIQ) that ties the laptops serial number to the asset tag which in turn makes sure that each deviced is assigned correctly when distributed to students.
- <u>iBenzer Protective Cases</u> All laptops goven to students have these cases to provide an additional layer of protection to the devices Our existing infrastructure handles the needed bandwidth for any additional devices. All laptops will be connected through the wireless network. Wireless infrastructure is currently up-to-date and provides full coverage throughout all schools.
