WHEREAS, on November 1, 2013 the Hempstead Classroom Teachers Association (“Union”) filed a grievance, pursuant to Article XXX of the collective bargaining agreement alleging that Roberta Bloom (“Bloom”), a teacher on special assignment for the 2012-2013 was not compensated for the work she performed beyond her contractual time; and

WHEREAS, the Superintendent of Schools has analyzed and examined the grievance; and

WHEREAS, the Superintendent of Schools has determined that the grievance is valid and should be resolved; and

WHEREAS, the Superintendent of Schools has determined that Bloom is entitled to additional compensation for 212 hours of work at her contractual rate for a total of \$17,152.92, as per the District’s collective bargaining agreement with the Union,
