1. WHEREAS, the Hempstead Union Free School District issued a bid for the construction of the athletic field located at the Hempstead High School; and

WHEREAS, bids were received from three (3) vendors and were opened and publicly read on March 15, 2023; and

WHEREAS, the District has been advised by BBS Architects, Landscape Architects and Engineers, P.C. ("BBS") that Laser Industries, Inc. is the lowest responsible bidder at a total cost of \$2,924,600;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education of the Hempstead Union Free School District hereby awards Bid number 22-248 for the construction of the athletic field located at Hempstead High School to Laser Industries, Inc.

RESOLUTION

2. WHEREAS, the Hempstead Union Free School District issued a bid for roof replacements at the David Patterson Elementary School, the Alverta B. Gray Schultz Middle School, and the Hempstead High School; and

WHEREAS, bids were received from seven (7) vendors and were opened and publicly read on March 15, 2023; and

WHEREAS, the District has been advised by BBS Architects, Landscape Architects and Engineers P.C. ("BBS") that More Consulting Corp. is the lowest responsible bidder at a total cost of \$10,126,000;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education of the Hempstead Union Free School District hereby awards Bid number 22-247 for roof replacements at the David Patterson Elementary School, the Alverta B. Gray Schultz Middle School, and the Hempstead High School to More Consulting Corp.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education of the Hempstead Union Free School District hereby awards Bid number 22-249 for the replacement of windows at the Jackson Main and Barak Obama Schools to Arrow Corp.
