that the Board found that misconduct was founded based upon the verbal report, and instructed the District Clerk to read the following resolutions.

Trustee Jackson moved, seconded by Trustee Figueroa to approve the removal resolution as written.

1. **WHEREAS**, the Board of Education of the Hempstead Union Free School district (“Board”) is duly constituted governance body of the School District; and,

WHEREAS, Lamont Johnson is a member of the Board bound by the district policy and legal requirement that he not disclose confidential information acquired by him in the course of his official duties as a member of the Board; and,

WHEREAS, the Board having heard and reviewed all of the evidence concerning the Notice of Removal dated June 8, 2017; and,

WE HEREBY FIND, that the Respondent Lamont Johnson is guilty of the charges set forth in the Notice of Removal dated June 8, 2017, and pursuant to the Board’s authority set forth in Education Law Section 1709 (18), the Board does hereby removed Lamont Johnson from the Hempstead School District Board of Education immediately.

Trustee Gates moved, that the resolution be suspended until Trustee Johnson’s witnesses have had an opportunity to testify.
